

# \$20,000 Members Badge Draw

**Terms and Conditions** 

### TERMS AND CONDITIONS

The Member's Badge Draw jackpots from \$1,000 to \$20,000 and is drawn every Monday & Wednesday evening. The first draw is at 6:30pm, followed by a 7:30pm and 8:30pm draw.

The 'draw' constitutes the physical announcement of the member's badge number only.

Members must be present within and inside the physical \*\*Clubhouse at the time of the draw (announcement) – a four (4) minute grace period to claim prize is then issued to members present in the Clubhouse should they be incapacitated at the time of the announcement.

\*\*The Clubhouse refers to the physical club building only situated at 103 New Line Rd, West Pennant Hills NSW 2125 and is not inclusive of Club carparks, footpaths, driveways, adjoining halls, buildings or properties.

No further draws will take place that evening if won.

### **Rules and Conditions**

In addition to the Conditions set out by the Department of Gaming and Racing the following approved rules and conditions apply:

- 1. A Members Badge Draw will be held twice per week, on Monday and Wednesday nights at 6:30pm, 7:30pm (unless won at an earlier draw) and 8:30pm (unless won at an earlier draw)
- 2. Start-up monies will be \$1,000, jackpotting by \$1,000 per week up to a maximum of \$20,000.
- 3. If proposed prize money is greater than \$2,000, the prize winner must be paid the amount exceeding \$5,000 by a crossed cheque made out to the winner member only (or by EFT if the winner so requests). The full prize amount can be paid in this manner, if desired and must be requested by the winner member on the date of winning.
- 4. The promotion will run from 31st August 2023 to 31st August 2026
- 5. Each night, there will be a maximum of three draws only, with a four (4) minute grace period for members already present in the Clubhouse at the time of the draw to present themselves, and their membership card to management.
- a) To claim the jackpot, members must have swiped their card at the Members kiosk at front reception on the day of the draw itself and prior to that particular draw to be eligible to claim the prize.
- 6. When the current Jackpot amount is claimed in any of the three (3) draws, the Jackpot amount will revert back to the starting amount for the next weeks draw. Once a Jackpot is claimed, no further draws will be conducted on that particular day.
- 7. After the Jackpot reaches \$20,000 and is not claimed for the next two (2) weeks, the following week a secondary draw will be conducted after the three regular daws, should they not be won, in the below manner:
  - a) A series of ten (10) draws for \$1,000 each commencing at 8:45pm will be made from a barrel of computer generated entry coupons.

- b) Entry coupons will be generated when the member makes a \$5 purchase over the bar or restaurant at any time during the day. Members are eligible to receive one (1) entry each. The member must then place this entry coupon into the barrel provided. Entry coupons will be generated up until 8.45pm on the night of the draw only.
- c) Members are subject to the same 'conditions of entry' rules as stipulated above to be eligible to claim a prize in the secondary draw.
- d) Any of the member's whose entry coupons are drawn and are no longer in attendance and don't come forward within four (4) minutes to claim their prize, then the draw will be repeated until all ten (10) x \$1,000 amounts have been claimed.
- e) Each member present is entitled to claim only one (1) of the ten (10) draws for \$1,000.
- f) After the completion of the ten (10) x \$1,000 draws, the badge draw will be reset at \$10,000 for the next weeks draw.
- 8. Senior management have the right in their sole discretion and without prior notice to alter the prize structure of the secondary draw, under the same conditions and rules, and give away the full \$20,000 prize instead of \$10,000 as described above. This can be done in values of:
  - a) One (1) x \$20,000 draw
  - b) Two (2) x \$10,000 draws
  - c) Four (4) x \$5,000 draws
  - d) Ten (10) x \$2,000 draws
  - e) Twenty (20) x \$1,000 draws
  - f) Or any combination of the above denominations equal to \$20,000 total
- 9. The following persons are not eligible to win or participate in the Badge Draw:
  - a) Any employee of West Pennant Hills Sports Club Limited, either currently employed or employed within the previous 12 months of the date of the draw;
  - b) Contracted and sub contracted employees of West Pennant Hills Sports Club Ltd, as well as their employees, including but not limited to Club tradesmen and the owners and employees of the caterer, whose services have been engaged in the previous 12 months of the date of the draw;
  - c) Suspended members, or any member with pending disciplinary actions against their membership;
  - d) Any non-financial member; and
  - e) Any member under the age of 18 years.
- 10. In the event that the winner is an individual listed in clause 9 above, a redraw will immediately occur.
- 11. Directors, who act in accordance with these Terms and Conditions, are eligible to claim the prize.
- 12. The member whose number is drawn must be present in the Clubhouse at the time of that said particular draw (announcement).
- 13. The member must then, within a four (4) minute period from the announcement come forward and claim their prize by producing their current financial membership card (badge).
- 14. <u>Review of Potential Winners:</u> The Club reserves the right to review the eligibility of all potential winners of the Members Badge Draw. This review process is designed to ensure the integrity of the draw and compliance with all applicable rules and conditions.
- 15. <u>Review Period:</u> Upon a member claiming to have won the Badge Draw, the Club shall have a period of forty-eight (48) hours to conduct a thorough review of the member's claim. This review period commences immediately following the draw in which the member claims to have won.
- 16. <u>Official Winner Declaration:</u> A member shall not be deemed an official winner of the Badge Draw until they receive formal notice in writing from the Club's CEO or Operations Manager. The written notice serves as the definitive confirmation of winning the draw.
- 17. <u>Exclusion of Unofficial Acknowledgements:</u> No acknowledgement, admission, or act by any Club staff, affiliates, or any individual associated with the Club shall be considered as confirmation of winning the Badge Draw. Members are advised that only the written notice as specified in Clause 16 above serves as official confirmation of winning.
- 18. By accepting the prize, the member agrees to participate in any publicity arrangements made by or on behalf of the Club in relation to this promotion. West Pennant Hills Sports Club Ltd reserves the right to publicise the winners' names and photograph through print, electronic media and broadcasts without permission or payment of any compensation to the winner and without prior notification.

- 19. Membership cards, numbers and entry tickets are not transferrable, and only the individual named and related to the winning membership number is eligible to claim the prize.
- 20. To the extent permissible by law, members release West Pennant Hills Sports Club Ltd from any causes of action, loss, liability, damage, expense (including claim for legal expense), cost or charge sustained or in any way incurred, as a result of participation in this promotion.
- 21. West Pennant Hills Sports Club Ltd in its sole and reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. West Pennant Hills Sports Club Ltd is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members or in the completion of entries to the promotion or in seeking to attend any draw or to attend the process of selecting a winner.
- 23. West Pennant Hills Sports Club Ltd is not responsible for members being located in areas within the Clubhouse in which announcements are not able to be heard, nor for the audible integrity of those announcements.
